		The national report on activities on the standardization of geographical names in the Republic of Croatia for 2021 was submitted to ECSEED/UNGEGN and published in the UNGEGN information bulletin.		
		The Commission for the Standardization of Geographical Names in 2022 held nine meetings and worked continuously, through its working groups, on four strategic documents (which are adopted) for the purpose of quality assurance of the Register of Geographical Names.		
		With the implementation of the new Law on Settlements, local self- government units are obliged to obtain the opinion of the Commission for the Standardization of Geographical Names on the proposed name of the settlement, street or square.		
		Activities (pilot project) on the revision of some records in the database of the Register of Geographical Names were completed with a review.		
		Writing one Recommendations for the standardization of geographic names in the Republic of Croatia; publication on geographical names; improving functionality of the network application of the Register of Geographical Names and upgrading website of the Register of Geographical Names are in process.		
		The Commission for Standardization of Geographical Names continuously gives its expert opinions to the users / interested public, related to the suggestions for naming and / or changing the geographical names of geographical objects in the Republic of Croatia.
